With reference to your application with ID No. **NW031720241230361** dated **09-01-2025**, and payment of spectrum charges of **Rs. 312500**, this Ministry hereby conveys its decision to grant Wireless Operating licence for establishing Wireless Telegraph Station(s) with the following parameters. This decision letter (DL) is **valid till 31-03-2026** i.e. ONE Year plus three months of construction period from first day of month of issue of Letter of Intent (LoI) dated 20-01-2025.

** Spectrum charges already paid at All India Level for PAN India Frequencies.

The above spectrum charges are payable annually before expiry of the DL in advance, to avoid late fee @2 percent per month or part thereof, compounded annually.

4. Licensee shall procure equipment adhering to the above parameters from dealers who are in possession of a valid Dealer Possession Licence (DPL) only. Mast Height/Full site clearance should be obtained for fixed stations (if any) as given in Annexure and clearance from SACFA section of WPC should be obtained. Thereafter copy of invoice containing details of equipment purchased, SACFA clearance & other relevant documents shall be submitted to WPC for issuing Wireless Operating licence. **Operation of wireless equipment should not be commenced before grant of Wireless Operating Licence.**

5. This is a system generated letter and no signature is required. The authenticity of this document can be verified by visiting the web link, accessible through the provided QR code.

The frequency assignment is subject the following conditions: -

- This assignment of spectrum is provisional and subject to Govt's decision on pricing of spectrum.
- In case this provisional assignment of spectrum is withdrawn, payment made towards spectrum charges, or part thereof, shall not be refunded.
- In case this provisional assignment of spectrum is withdrawn, the Licensee shall obtain Non-Dealer Possession Licence (NDPL) for possessing the wireless equipment or return the equipment to a DPL holder or shall dispose of the wireless equipment as per procedure.
- Revised spectrum charges, if applicable, shall be paid by us from the date of Letter of Intent (LoI) for provisional assignment of spectrum.

Upon any shift/ change in allotment policy due notice of 3 months of such change, time to make appropriate arrangements, will be given and the same has to be complied with by the wireless users.
