**WALK-IN-INTERVIEW FOR THE POST OF CONTRACT MEDICAL

A Walk-in-Interview will be conducted to form a panel of doctors for their engagement as "Contract Medical Practitioners" on full-time contract basis for one year duration in Chittaranjan Locomotive Works/Chittaranjan on the following terms and conditions:-

1. **Name of the post:** Contract Medical Practitioner (CMP)
2. **No. of Posts:** 04(four): No. of vacancies may increase or decrease subject to the appointment of regular IRHS officers.

- (i) If no Specialists are found then above three posts will be filled up by CMP(GDMO)
 - (ii) In case of non-availability of OBC candidates, UR candidates will be engaged as CMP.
 - (ii) CMPs can be posted anywhere in Health Unit, Dispensary, Hospital etc. in CLW as per requirement.
3. **Age:** (a) Entry level age not exceeding 53 years as on 04-03-2024 (3 years age relaxation for OBC).
(b) Maximum age limit is 65 years or 12 terms whichever is earlier and each term of engagement shall not exceed more than one year.
(c) In case of Retired Railway/Government Doctors: Maximum age limit is 67 years or 07 terms whichever is earlier and each term of engagement shall not exceed more than one year.

4. Educational/Technical Qualification:-

- i) **GDMOs:-** MBBS from a recognized University and must have completed one year rotating internship and should be in possession of a valid Registration Certificate issued by any of the State Medical Councils/Medical Councils of India.
- ii) **Specialists (Orthopedics/Physician/Surgeon):** MBBS with Post Graduate Degree/Diploma in the respective field of specialty recognized by MCI and should be in possession of a valid Registration Certificate issued by any of the State Medical Councils/Medical Councils of India.

5.a) Remuneration:

Category of CMP	Monthly remuneration
General Duty Medical Practitioner (GDMO)	Rs.75,000/-
Specialists (1 st year)	Rs.95,000/-
Specialists (2 nd year onwards)	Rs.1,05,000/-
For Retired Railway/Government Doctor	Rs.75000/- subject to the condition that the remuneration + pension drawn by retired doctor should not exceed the last pay drawn at the time of retirement.

5.b) In case Govt. accommodation is provided to a Contract Medical Practitioner, an amount equivalent to the sum of HRA and license fee of the accommodation so provided will be deducted from the monthly remuneration as per rules.

6. **Nature of Engagement:** The engagement is purely on contractual basis for one year or till regular UPSC selected Doctors become available whichever is earlier. Further, the services of these doctors are also terminable before the expiry of one year. The services rendered as contract doctors is a stop gap arrangement and will not have any bearing in respect of consideration of their period in case of regular selection through UPSC. It will also not confer any right for automatic regularization/absorption. The contract shall liable to be terminated by giving 15 days notice by either side without assigning any reason, or if the Contract Medical Practitioner is mentally/physically incapacitated.

7. **Other Facilities:** Subject to extant rules being applicable, the following facilities may be extended:-

- a) One set of 1st class complementary Pass for self & family during each contract shall be issued after three months of regular contract service. No Passes/PTOs shall be admissible to retired Railway doctors engaged as CMP.
- b) Contract Medical Practitioners can avail themselves of free medical treatment for self only (except Retired Railway Doctors).
- c) Expenses on out station journey connected with contracted work will be borne by the Railway. Daily allowance at specified rates will be admissible for such work.
