

TECHNICAL SPECIFICATION OF MERCHANT FLAT BARS FOR USE ON 3-PHASE A.C. FRIEGHT WAG-9 (CO-CO) & WAP-5 (BO-BO) ELECTRIC LOCOS FOR INDIAN RAILWAYS

1. <u>SCOPE</u>:

This specification covers the minimum requirement of design, manufacturing and supply condition of Merchant Flat Bars for use on WAG-9 (Co-Co) & WAP-5, 3-phase electric locos for Indian Railways.

2. SCOPE OF SUPPLY:

Merchant Flat Bars to be supplied per loco, in a set, as per attached Annexure-A for WAG-9 (Co-Co) loco & Annexure-B for WAP-5 loco of this specification. The quantity of each item per set shall be equal to quantity per loco indicated in the individual drg/as mentioned in ref. category noted below Annexure-A & Annexure-B.

3. **GENERAL**:

Merchant flat bars are of steel used in loco at various location to ease the production time cycle.

4. <u>TECHNICAL REQUIREMENT</u>:

- **4.1.** Steel plate used in making flats shall be corrosion resistant and conform to IRS: M-41 Gr.I & IS:2062:2011 Gr.E250 Cu Quality-C Killed Normalized.
- **4.2.** Flats are to be clean cut, Edges clearly sheared and truly squared to the specified dimension.
- **4.3.** Finished material shall be free from cracks, flaws, lamination, rough jogged and imperfect edges and other harmful defects.
- **4.4.** Each flat shall be straight and square to the edge. Deformation is not acceptable.
- **4.5.** Metal shall not be effected/corroded when exposed in 100% relative humidity or max. ambient temperature of 80°C or heavy rain fall.

5. MANUFACTURE:

- **5.1.** Flats shall be manufactured from corrosion resistant steel conforming to IS:2062:2011 Gr.E250 Cu Quality-C Killed Normalized.
- **5.2.** Anti-corrosion treatment to be done before supplying the material.
- **5.3.** Weight of each finished product shall be within the specified limit.
- **5.4.** Surface shall be finished with proper method.

6. INSPECTION AND TESTING:

6.1. Inspection be done by authorized representative of CLW at manufacturer's works premises. Any failure/defect noticed during inspection shall immediately be rejected/replaced.

- **6.2.** Tensile test, bend test to be conducted and certificate to be produced during inspection, which will be arranged & borne by supplier.
- **6.3.** Material test certificate to be submitted during inspection. Test piece can also be collected for further M&C Exam.

7. QUALITY ASSURANCE:

As per ISO: 9000:2015 or latest.

8. PACKING & DELIVERY:

- 8.1. Protective packaging to be done, with trade mark, which is suitable for the transport and storage under climatic and environmental condition as stipulated, which will prevent any damage to the material during handle, transit and storage.
- 8.2. The product shall be given temporary rust preventive coating for protection during storage and Transit
- 8.3. Each item shall be marked with supplier's trade mark and date.
- 8.4. Tenderer can contact CLW Design office for any technical clarification in doubt if any.
- 8.5. Prior to prototype inspection CLW'S representative will be deputed to seal the sample piece of the material specified for test in the government approved/ RDSO approved test lab. The lab test report should be produced at the time of prototype inspection.
