No.: -22 and above the name of Sri Ujjwal Kumar, T/No.: -60/041, Control No.: -51101429122 appearing at Sl. No.: -23 in the seniority list of JE/Elect. vide ADDENDUM No.: -MW/E-XI/E/S-19/JE (E), dated: -28.07.2023.

Consequent upon fixation of seniority in terms of ADDENDUM dated: -28.07.2023 and having being found suitable in the suitability test based on paper scrutiny, Sri Subhendu Das is promoted to the post of SSE/Elect. in Level-7 of 7th CPC pay matrix on Proforma basis w.e.f. 24.12.2021 i.e., from the date of promotion of his erstwhile junior Sri Ujjwal Kumar, Desig.: -SSE/Elect, Control No.: - 51101429122, B.U. The pay on promotion of the above staff as SSE/Elect. is to be fixed by the concerned Estt. Section on receipt of the report of shouldering higher responsibility.

The pay and allowances of the above staff in promotional grade as SSE/Elect. should be drawn only from the date when incumbent shoulder the charges of the higher post and he is eligible for PCO allowance as applicable.

The above promotion is provisional and will not confer on him any claim/right for seniority over his seniors, if any, who could not be promoted as such as yet due to obvious reasons.

The staff concerned is advised to exercise option for the fixation on promotion within "ONE MONTH" from the date of issue of this fixation of promotional pay either from the date of promotion or from the date of next increment in terms of Rly. Board's L.No.-PC/VII/2016/1/6/2 dated:-31.06.2017 (RBE No.-79/2017). Failure to exercise option within stipulated time due to ignorance or otherwise will not be entertained in any case in future in terms of Rly. Board's order circulated in CPO's L/No.: -GMA/Ruling/81(7), dated:-08.08.2017 (CPO' SI No.-70/2017).
