
The pay of the staff on promotion may be fixed up from the concerned Establishment section on receipt the letter of the higher responsibility in accordance with instruction laid down in RSRP rules under the 7th CPC, 2016. The pay and allowances of the above mentioned staff in higher grade should be drawn only from the date of incumbent shoulder the charges of the higher post.

The staff concerned is advised to exercise the option for fixation of his pay on promotion within "one month" from the date of issue of this order for fixation of promotional pay either from the date of promotion or from the date of next increment in terms of Rly. Board's Letter No. PC/VII/2016/1/6/2 dated- 31/6/2017 (RBE No. 79/2017).

In terms of RB's order circulated under PCPO/CLW's circular No. GMA/Ruling/170(13) dated- 20/6/2003, Sl. No. 61/2003, the employees who have been ordered for transfer on promotion and posted to work in the place other than present place of work should not be detained on any reason whatsoever and it would be the responsibility of the controlling officer to release the employees from their existing place of work.

The above promotion is provisional subject to outcome of the SLP No. 4831/2012 and contempt petition No. 314/2016 in terms of Rly. Board's Letter No. 2016-E(SCT)1/25/8 Dated- 30/9/2016 (RBE No. 117/2016) and will not confer on them any claim/ right for seniority over their seniors, if any who could not be promoted as yet due to obvious reason.


