

- a. The Contractor shall keep the said Logistic hub open round the clock. He/She will have to provide a whole time staff adequately for ensuring Cleaning, Watchman, Services at his own cost for rendering work, service as are normally required in connection with the parking/ logistic hub. He/She shall ensure proper parking of vehicles.
