

**OFFICE ORDER**

**Sub.:-**Posting of serving erstwhile Gr.-D staff to inside workshop against 40% induction quota.  
**Ref.:-**This office notice of even no. dated 12/04/2018 and 15/05/2021

As a result of provisional screening test held between 22.02.2021 to 27.02.2021, total 121 nos. serving Gr.-D staff working outside the workshop have been declared suitable by the Screening Committee for their induction to inside the workshop against 40% induction quota, in their existing capacity, pay and grade, with bottom seniority. One candidate has been reported expired.

As such, total **120 nos.** candidates, who have been found suitable in the screening test, their names have been arranged as per inter-se-seniority amongst them, the said 120 nos. Gr.D staff are hereby ordered for their posting as Helper under Loco Works as indicated against each with immediate effect, as per the names mentioned under "Annexure -A". The said list is provisional.



The SSEs/Incharge of Sections are also advised that the "Joining Report" of the Helpers may be sent to the concerned Establishment Sections for record and needful action. Necessary E.O. will be issued from the concerned Establishment Sections, as per extant rules.
