#### RULES FOR TECHNICAL /PROFESSIONAL SCHOLARSHIP UNDER SBF/CLW

- 1. The scholarships will be available for sons & daughters, dependent brothers & sisters of non gazetted employees in Substantive Grade Pay Rs 1800/- and above as per 6th CPC i.e from level 1 onwards of 7th CPC as on 01.04.2021
- 2. The scholarship is only meant for the wards, who are pursuing professional/technical course of studies and not for general courses of studies, like conventional B.A./B.Sc./B.Com. etc.
- 3. The courses offered by Open Universitites/Institutions through correspondence are not eligible for scholarship.
- 4. The scholarship will be payable from the date of admission into a particular institute or class from which Technical/Professional education.
- 5. The technical scholarships granted to candidates may be continued, in cases where no failures or detention in the same class and the candidates is allowed to continue studies in the next higher class. For detention/failure during the course of studies, scholarship is not admissible, unless he/she is promoted to next class.
- 6. The Scholarships once granted will not be affected by the death, invalidation or retirement or superannuation of the employee .However, if any employee resigns from service, he will lose his scholarships sanctioned to his children or dependent brothers /sisters.
- 7. Staff/students who are in receipt of any scholarships or assistance from any other source are not eligible for Technical scholarships. The application should be accompanied by a certificate from the institution where the ward is studying that the ward is not in receipt of any scholarship of financial assistance from the institution or from any other source as per Annexure-III.
- 8. If both the applicant and his /her wife/husband are Govt. employees, the full particulars of income of the Husband/Wife of the applicant will have to be furnished.
