As a result of screening test held on 22.02.2021, 23.02.2021, 24.02.2021, 25.02.2021, 26.02.2021 & 27.02.2021, a list of 121 nos. candidates from amongst the serving erstwhile Gr.-'D' staff working outside the workshop have been considered "**suitable/provisionally suitable**" by the Screening Committee against the Notice No.MW/MR/21/Part X(Panel) dated 12/04/2018 for transfer to Loco Works/Steel Foundry(SF) against 40% Induction Quota, on their existing pay in Level-1 of 7th CPC Pay Matrix with bottom seniority.


