The candidates are advised to report to the Medical Section (E-IX), PCPO's Office CLW/Chittaranjan from 10.00 hrs. to 17.00 hrs., failing which their candidature will be treated as cancelled.**
3. The candidates are selected for COVID-19 situation only.
4. Initially they are engaged for a period of three months only.
5. They shall be put to work in quarantine /isolation facility, wards of K.G. Hospital.
6. The paramedics will be required to follow necessary protocol/ guidelines as issued by competent authority from time to time.
7. The candidates in the above list, who enters into Contract with the Railways, will not have any claim or right for automatic regularization or absorption in the Railways. Candidates engaged in the Railways on contract basis will not have any claim or right for his/her continuity in service or automatic extension of the terms on the contract. These services will be terminated at the end of the contract period.
