Sub : Submission of Application for allotment of Adjacent vacant Quarters in 'A/I' type Quarters only.


Applications are invited from eligible staff of CLW (from all Departments) towards allotment of Adjacent vacant Quarters of 'A/I' type from Central Pool under Dy. CPO(W). The procedure & criteria for allotment of adjacent vacant quarters are appended below:

1. Criteria :

- (i) Remaining vacant 'A/I' type quarters after Online Spot allotment vide Notification No. MW/104/Qrs. (Spot Allotment)/1905 dtd. 22.05.2020 will only be considered for allotment against this Notice.
- (ii) 01 (One) unit of vacant quarter in 'A/I' type will be allotted to the staff who are already allotted & residing in the adjacent vacant quarters. (For 'A' type, only A with B and C with D quarters in a same block will be allotted).
- (iii) Staff of all category/Grade Pay are eligible to apply for the above allotment.
- (iv) No change in quarter structure will be done.
- (v) Quarter Rent will be just double of Normal Rent/License fee.
- (vi) Refusal of Quarters (after allotment), shall be debarred for 01(one) year towards allotment of any type of quarters.

2. How to apply

- (i) Employee must apply on the application Format (issued from Quarter Sec. only). No other application will be entertained.
- (ii) Last date of submission of application is 10.08.2020.
- (iii) Application addressed to Dy. CPO(W) may be sent to E Mail Id No. dycpow@clw.railnet.gov.in within 10.08.2020.
- (iv) Administration reserves right to change/amend /cancel the Notification at any time if required.
