**RE-ENGAGEMENT OF RETIRED RAILWAY EMPLOYEES IN INSPECTION CELL OF
MUMBAI/CHITTARANJAN LOCOMOTIVE WORKS**

Applications are invited from retired Railway employees below 65 years of age for **01 (One)** post of **Protocol cum Liaison Inspector**/Inspection Cell/Mumbai/ Chittaranjan Locomotive Works:-

The following terms and conditions are to be noted:-


- I. Retired Railway employees from any railway can apply. Last date of application is 10-07-2019.
- II. The re-engagement shall be strictly up to the age of 65 years or till the availability of regular candidates from RRBs/RRCs whichever is earlier.
- III. On joining of selected candidates from RRBs/RRCs, the re-engaged employees will be dis-engaged first.
- IV. If any adverse report is given against the re-engaged employee during re-engagement by the Controlling Authority, then re-engaged employee will be dis-engaged forthwith without any prior notice.
- V. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
- VI. Re-engagement shall be subject to prescribed medical fitness for the category in which they are re-engaged.
- VII. Suitability / Competency of the applicant shall be adjudged by nominated committee before re-engagement.
- VIII. No re-engagement will be done for the category of Loco Pilot, Guard and Controllers. However, staff who retired from these categories are free to apply for any other relevant Stationary duty/post.
- IX. Monthly remuneration of a retired employee being re-engaged will be determined by reducing Pension from his/her last pay drawn (i.e. Basic Pay + DA.). Payment will be made strictly on no-work-no-pay basis.
- X. The duty hours of the re-engaged employees would be as prescribed by Competent Authority as per the working conditions of the category.
- XI. Applicant should be willing to work anywhere in the jurisdiction of Chittaranjan Locomotive Works (i.e. Chittaranjan, Dankuni, Kolkata, Mumbai, Delhi, Bengaluru).
- XII. Applications should be addressed to Principal Chief Personnel Officer, General Manager's Office, Chittaranjan Locomotive Works, PO – Chittaranjan, Dist. West Bardhaman, PIN – 713331 and sent by ordinary post or may be dropped in the Box kept at Dispatch Section of Dy.
