In order to enquire into the charges as levelled against the employees mentioned above, an Inquiry Officer was nominated to conduct the D&AR enquiry. Now, the enquiry has been concluded after giving reasonable opportunity to defend their cases and now the punishment will be imposed against them under the provision of D&A Rules-1968.

Therefore, the above mentioned Charged officials (C.O.) are hereby once again advised that if they want to say anything against the said Charge Sheet (SF-5) as indicated against their name may submit their written statement to the Disciplinary Authority within 10 (Ten) days from the date of publication of this Notice.

Failing which, ex-parte decision will be taken by the respective Disciplinary Authority, and "Major Penalty" punishment will be imposed upon them accordingly.
