The selection will consist of the following test:

- a) **Written Test:** Written test consist of a test in English Grammar (including Punctuation). The paper in English will be designed to test the candidate knowledge of Grammar and composition and generally his/her ability to write and understand correct and idiomatic English and there will be question for 10% marks in Official Language in terms of Railway Boards letter No. Hindi 84/OL-1/10/3 dated 03.11.1988. The question paper will be 100% objective type as per RBE No. 196/2018. The time of the written examination will be 02 hours and 30 minutes. (100 marks)
- b) **Skill Test:** Stenography skill test as prescribed as per instruction given below:
